Call your Congressman in DC & say the following:

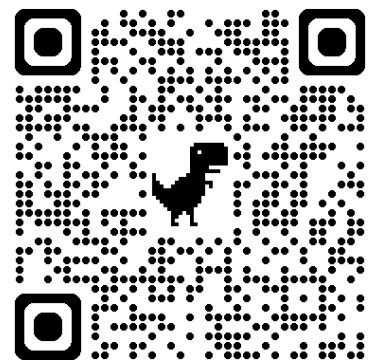
